Sir,

I am to refer to the subject cited above and to enclose a copy of Psara License bearing No. PSA/L/71/HP/2026/AUG/3/458 issued in favour of above mention Security Agency to run the business of Private Security Agency within in the Himachal Pradesh. You are, directed to comply with all the mandatory provisions of the Private Security Agencies (Regulation) Act-2005 & Himachal Pradesh Rules-2020-2021. The permission is granted subject to the following conditions:-

- 1) Security guards recruited by your firm for the purpose have undergone mandatory training at recognized training institute in H.P., strictly in accordance with the Private Security Agencies (Regulation) Act, 2005 & Rules, 2020-2021.
- 2) Inform the Controlling Authority regarding any change in the address of persons forming the Agency and change of management within thirty days of such change.
- 3) Inform the Controlling Authority about any criminal charge framed against the persons forming the agency or against any guard or supervisor engaged or employed by the security agency. A copy of such communication shall also be sent to the officer in charge of the police station where the person charged has his permanent residence.
- 4) Agency is operating under a valid licence issued by the Controlling Authority and the same be exhibited in a conspicuous place of its business.
- 5) Maintain a register as per rule 14 of HP Private Security Agencies (Regulation) Rules, 2020-2021.
- 6) Issue photo identity cards as per rule 15 of HP Private Security Agencies (Regulation) Rules, 2020-2021 to all the security guards employed or engaged by you.

Verify the character & antecedents as per rule 4 of HP Private Security Agencies (Regulation) Rules, of all the guards and supervisors employed or engaged by you.

7) As per rule 8 of HP Private Security Agencies (Regulation) Rules, 2020-2021, the uniform and badges provided to the guards by the Security Agencies shall not be similar to that of Army, Navy, Air Force, BSF, CPOs or any State Police or central

8) and state Govt. or Armed Police Forces in India. It may be ascertained whether the provisions of this rules are being followed.

Agency shall issue and make it obligatory for its guards to put on while on duty; in addition to the uniform:-

- (a) An arm badge distinguishing the agency;
- (b) Shoulder or chest badge to indicate his position in the organization;
- (c) Whistle attached to the cord and to be kept in the left pocket;
- (d) Shoed with eyelet and laces; and
- (e) Headgear, which may also carry the distinguishing mark of the agency.

Every security guard shall while on duty, carry a note book and a writing instrument with him.

Every guard while on active security duty shall wear and display photo identity card issued under section 17 of the Act, on the outer most garments above waist on his person in a conspicuous manner.

The application for the renewal of licence should be submitted 45 days advance before the expiry of licence.
