ANNEXURE

(SERIAL NO. PSA/L/80/PY/2022/JUL/3/52)

CONDITIONS FOR THE LICENSE FOR RUNNING THE BUSINESS OF PRIVATE SECURITY AGENCY:

1. The licensee shall successfully undergo a training relating to the private security service within the period of six months from the date of issue of license and to intimate the same to the Controlling Authority as specified in Rule 10 (1) of Puducherry Private Security Agencies (Regulation) Rules, 2009.
2. The licensee shall intimate the name, parentage, date of birth, permanent address, and address for correspondence and the principle profession of each person forming the agency within fifteen days of receipt of the license to the Controlling Authority as per Rule 10(2) of Puducherry Private Security Agencies (Regulation) Rules, 2009.
3. The licensee shall inform the Controlling Authority regarding any change in the address of persons forming the Agency, change of management within seven days of such change as per Rule 10(3) of Puducherry Private Security Agencies (Regulation) Rules, 2009.
4. The licensee shall immediately intimate to the Controlling Authority about any criminal charge framed against the persons forming the agency or against the private security guard or supervisor engaged or employed by the agency, in the course of their performance of duties as private security agency. A copy of such communication shall also be sent to the officer in charge of the police station where the person charged against resides as per Rule 10(4) of Puducherry Private Security Agencies (Regulation) Rules, 2009.
5. The licensee shall engage or employee any person who is a citizen of India and has completed 18 years of age but not attained the age of 65 years and give preference to a person who has served as a member of an Ex-servicemen, Ex-CAPE, Ex-Police & Home Guards.
6. Every licensee shall abide by the requirements of physical standards for the private security guards and their training as prescribed in these rules as the condition on which the license is granted as per Rule 10 (5) of Puducherry Private Security Agencies (Regulation) Rules, 2009.
7. As per Rule 14 of Puducherry Private Security Agencies (Regulation) Rules, 2009, every private security agency shall maintain the registers as specified in Form VIII of the above Rule.
8. A separate uniform other than the uniform of Army, Navy, Air Force or any other Armed Forces of the Union or Police or any dress having appearance or bearing any of the distinctive marks of that uniform shall be provided.
9. The Private Security Agency shall ensure that the security guards employed by them will have to successfully undergo the training as per the training syllabus notified by the Home Department in G.O. Ms. No. 32 dated 26.7.2010 and to submit a list of successful trainees to the Controlling Authority as per Rule 5 (5) of the Puducherry Private Security Agencies (Regulation) Rules, 2009.
10. The licensee shall issue a photo identity card to every private security guard / supervisor as prescribed in Form-IX of the Rule 15 of the Puducherry Private Security Agencies (Regulation) Rules, 2009 and they will produce it on inspection by the Controlling Authority or any other officer authorized by him in this behalf.
11. **The licensee shall not engage armed security guard.**
12. The license /copy of the licensee shall be exhibited in a conspicuous place of its business.
13. **The application for renewal of license should be made to the Controlling Authority not less than 45 days before the expiry of the period of validity of license as per rule 8(1) of the Private Security Agencies (Regulation) Act, 2005.**
14. The Private Security Agency shall abide on all the conditions prescribed in the Private Security Agencies (Regulation) Act, 2005 and the Puducherry Private Security Agencies (Regulation) Rules, 2009.
15. The Controlling Authority has every right to cancel the license at any time who have not abide by the conditions prescribed in the Act and Rules.
